PRIVACY POLICY

- 1) Trieste Lines S.r.L., with headquarters in Via San Nicolò 15, Trieste, Italy, VAT No. 01017580323, website www.triestelines.it, guarantees that all the information gathered will be processed, in manual and/or automated form, in observance of the Italian Data Protection Code (Italian Legislative Decree No. 196 dated 30 June 2003 and subsequent amendments) and, if applicable, Italian Ministerial Decree dated 13 October 1999. In its capacity as sole *data controller*, Trieste Lines S.r.L. acknowledges the right of whomever to protection of the data which concerns them (Article 1 of Italian Legislative Decree No. 196/2003 and subsequent amendments) and guarantees the processing of the same in observance of the fundamental rights and freedoms, as well as the dignity, of the data subject, with particular reference to confidentiality, personal identity and the right to protection of personal data (Article 2).
- 2) Any "sensitive" data (Article 4.1, letter d) will be processed in observance of Authorisations No. 2/2014 and 5/2014 issued by the Italian Data Protection Authority. Subject to any legal obligations, Trieste Lines S.r.L. declares that it does not store any information relating to navigation data.
- 3) Guaranteeing the "minimum" use of personal and identifying data (Article 3), Trieste Lines S.r.L. declares, pursuant to Article 11, that the personal data shall be processed in a lawful manner and according to propriety, gathered and registered for specific, explicit and legitimate, precise purposes and, if necessary, up-dated, pertinent, complete and not in excess with respect to the purposes of the processing, kept in a form which permits the identification of the data subject and for a period of time no longer than that necessary for the purposes for which it was gathered or subsequently processed.
- 4) Pursuant to Article 13, Trieste Lines S.r.L. hereby informs the data subjects that:
 - the gathering and processing of personal data may be carried out by means of manual and/or IT instruments and the same is for the exclusive use of the services offered by Trieste Lines S.r.L.;
 - the mandatory or optional nature of the conferral of data shall be specified as and when the data is gathered;
 - refusal to confer the personal data indicated as mandatory, or refusal

- 5) At any time, the data subject may exercise the right to access personal data and other rights as per Article 7, forwarding a request to the data controller via registered letter, fax message or e-mail to be sent to the headquarters of the company indicated in point 1).
- 6) In the event of termination of the processing, for any reason, the data gathered shall be processed in accordance with the provisions laid down in Article 16.
- 7) Navigation of the website www.usticalines.it does not require personal data to be sent. The optional sending of e-mail messages to the account **info@triestelines.it** shall lead to the acquisition of the sender's e-mail address, as well as the other data included in the message, for the purpose of dealing with any requests. In replying, Trieste Lines S.r.L. shall send the data subject appropriate disclosure on the processing of the personal data contained in the e-mail.
- 8) Pursuant to the general Provision dated 8 May 2014 of the Italian Data Protection Authority (Italian Official Gazette No. 126 dated 3 June 2014), Trieste Lines S.r.L. declares that it does not gather, via navigation within the website www.triestelines.it, information on the users or which makes it possible to identify the computer or browser of the users, by means of cookies. It is hereby specified that any "session cookies" possibly used on the website www.usticalines.it are only stored temporarily and in a non-persistent manner on the terminal of the user and solely involve the transmission of session identifiers for the exclusive purpose of facilitating access to the contents of the website, thus not permitting the acquisition of the personal data of the user.
